**MEMORANDUM**

The Hon'ble High Court of Madras, Chennai had directed to implement the award of the Labour Court vide Order dated 27.04.2018 in W.A.No.436/2014. Accordingly, out of 30 labourers involved in the case, 13 labourers had attained the age of 60/expired and only 17 labourers are available for re-engagement. Accordingly, the 17 Labourers have been re-engaged in the State Seed Farm, Madur, Karaikal and only 16 have reported for duty on 10.06.2019. A tentative seniority list of the FTCLRs engaged above has been issued vide Memorandum No. 3303(A)/Agri./Estt/A6/2020 dated 14.10.2020 placing them with reference to their date of re-engagement i.e, w.e.f.10.06.2019. However, they have objected the seniority stating that it is not in accordance with the Court Order. The Department of Personnel and Administrative Reforms(PW) has also observed the same. Their actual date of engagement is not available with the Department. As such, they may be treated as engaged from the date of order passed by the Labour Court Karaikal i.e., on 24.01.2003 and their seniority will be fixed enblock on the date. Accordingly, tentative revised seniority list is issued assigning tentative seniority between 398 and 399 i.e., from 398-A- to 398-AD on the basis of their date of birth among those individuals and placed above U.Chandra(FTCLR Seniority No399 date of engagement 18.11.2005).

2. Objections to the seniority proposed to be assigned to the Full Time Casual Labourer may be submitted to the undersigned in writing on or before **26.02.2021**.

3. If no objection is received within the date mentioned above, it will be presumed that the individuals concerned have nothing to represent against their seniority etc., indicated therein and the final seniority list will be issued accordingly.

4. The above assignment of seniority is subject to the outcome of the CMP No.14638/2020 pending before the Hon'ble High Court of Madras.
