
On the recommendations of the Departmental Promotion Committee, the Mazdoors mentioned in the Annexure on absorption to the post of Demonstration Assistant purely on Ad-hoc basis are posted in the offices noted against each with immediate effect.

2. They will continue to draw pay in Level-1 in the Pay Matrix and other usual allowances as admissible under the rules in force from time to time.

3. The Officials are directed to report for duty **on or before 01.03.2019**, failing which it will be presumed that he/she has declined the offer and he/she will not be considered for absorption to the post of Demonstration Assistant for a period of one year or next DPC whichever is later, from the date of issue of this order.

4. They should undergo in-service training for a period of 3 months in the Vocational Agricultural School, Krishi Vigyan Kendra, Karaikal / Perunthalaivar Kamaraj Krishi Vigyan Kendra, Puducherry

5. The absorption is subject to the outcome of the pending O.A.815/2014 and O.A.No.1650/2016 before the Hon'ble Central Administrative Tribunal, Madras Bench and necessary entries should be made to this effect in the Service Book of the individual concerned.


