Subject Matter Specialist working in the PKKVK with 15 years of service rendered after appointment thereto on regular basis and

possessing Essential Qualification :-

- a) For Disciplines other than Engineering subject
Doctoral degree or Masters degree in the field of Agriculture / Horticulture / Animal Science / Fisheries/ Home Science
- b) For Engineering Disciplines
Doctoral Degree in the field of Agriculture Engineering
Or
Masters Degree in the field of Agriculture Engineering :

Will also be considered for the post and in case he/she is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

DEPUTATION

Officers under the Central/State Governments/Union Territories/Universities/ ICAR Recognized Research Institutions

Possessing Essential Qualification :-

- i. Doctoral degree or Masters degree in the field of Agriculture / Horticulture / Animal Science / Fisheries/ Home Science;
or
Doctoral Degree in the field of Agriculture Engineering

And

(a) (i) holding analogous posts on regular basis in the parent cadre/department; or

(ii) with five years service in the grade rendered after appointment thereto on regular basis in posts in PayBand-3 : 15,600-39,100 + Grade Pay 5.400 or equivalent in the parent cadre/ department; and,.

(b) (i) Officers from Department of Agriculture & Farmers Welfare, Puducherry working in the cadre of

(i) Additional Director of Agriculture; or

(ii) Joint Director of Agriculture with five years service in the grade rendered after appointment thereto on regular basis

Note: 1 The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or Department of the Central / State Government or Union Territory Administration shall ordinarily not exceed three years.

Note: 2 The maximum age limit for appointment by deputation shall be "Not exceeding 56 years" as on the closing date of receipt of applications.

Note: 3 For the purpose of appointment on deputation / promotion, the service rendered on a regular basis by an officer prior to 01.01.2006 / the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of

the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay / Pay Scale and where this benefit will extend only for the post or posts for which that Grade Pay / Pay Scale is the normal replacement grade without any upgradation.

Note: 4 The Officials of PKKVK in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
