NOTIFICATION

Sub: PPCC – Filling up of the post of Scientist ‘C’ (Rs.15600-39100 GP. Rs.5400/-) in the Puducherry Pollution control committee, Puducherry (autonomous) on deputation basis – Reg.

The undersigned is directed to inform that one post of Scientist - ‘C’(Rs.15600 – 39100 + G.P.5400) in the Puducherry Pollution Control Committee, Puducherry (autonomous) is to be filled up on deputation basis (including short term contract) among the eligible officers serving under Central Government / State Government Union Territories / Autonomous or Statutory Organizations / Recognized Research Institutions / Public Sector Undertakings / Universities. The details of the eligibility criteria etc. are as follows:

I. Eligibility for Scientist – “C” (Group ‘A’ Rs.15600 – 39100 + GP.5400/-)

- (i) Holding analogous posts on regular basis, or
- (ii) Having at least 2 years regular service in posts in PB.-2 with Grade pay of Rs.4800/- ; or
- (iii) Having at least 3 years regular service in posts in PB.-2 with Grade Pay of Rs.4600/-

Essential Education Qualification for Scientist - ‘C’:

- (i) Master Degree in Chemistry /Bio- Chemistry / Micro-Biology / Environmental Science / Ecology from a recognized university.
- (ii) 5 years experience in Environmental quality management and Pollution Control activities or research work in relevant fields.

(The Scientist “B” in the Puducherry Pollution Control Committee with 3 years regular service in the post will also be considered and in case he is selected for appointment to the post, the same shall be deemed to have been filled by promotion)

Note:-1 : The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion”.

Note:-2 : The maximum age limit for appointment by deputation shall be “Not exceeding 56 years” on the closing date for receipt of applications.

1. The officers selected on deputation for the post will be governed by the terms and conditions laid down in Government of India , Department of Personnel and Training O.M. No.6/8/2009-Estt.(pay II) dated 17th June 2010 as amended from time to time . The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization / Department of the Central / State Government shall ordinarily not to exceed 3 years. Place of posting will be in Puducherry.
2. The application (in duplicate) in the enclosed Proforma along with the complete and up to date annual confidential reports for the last five Years may be sent to this Committee within 60 days from the date of issue of the publications.
3. While forwarding the applications, it may please be confirmed that no disciplinary / vigilance case is either pending or contemplated against the officer. The application must be accompanied by the following documents:-
 - i. C.R. Dossiers / Photocopies of ACR / APARs of last five years duly attested by Group ‘A’ officer.
 - ii. Vigilance clearance
 - iii. Integrity certificate
 - iv. Major / Minor penalty statement for the last 10 years.
5. Applications received after the last date or without the Confidential Reports Dossiers or otherwise found incomplete will not be considered. While forwarding the applications it may be verified and certified that the particulars furnished by the Officers are correct and no disciplinary case is pending or contemplated against the Office. The applicants may please be informed that they will not be permitted to withdraw their application.
