ORDER

Sub : Agriculture - Representation from Farmers - Declaration of Command area under Ariyur Sugar factory & Puducherry Co-operative Sugar Mills Ltd, Puducherry as common area - Orders issued - Regarding.

Ref : This Directorate's Order No. 5532/DA&FW/2021/J(S) dt.13/11/2021.

In exercise of the Powers conferred under clause (6) of Sugarcane (Control) Order 1966, the Sugarcane Commissioner of Puducherry has ordered for temporary allotment of villages to protect interest of the farming community, sugarcane area as falling the command of M/s. E.I.D. Parry (India) Ltd, Ariyur sugar mills and Puducherry Co-operative Sugar Mills Ltd to the nearby sugar mills, vide order cited under reference.

2. Whereas, representations were received from the different sections of sugarcane growers seeking modification in the orders, so as to enable them to register and supply cane to the sugar mills of their choice. And the matter was examined, there is conflict of views from the different sections of farming community to decide at the sugar mills of their choice. The interest of all sections of farmers of the individual village could not be satisfied by demarking an individual village to a particular sugar mill. After considering the views of the all sections of farmers, stake holders etc., it is decided to withdraw the order issued vide reference cited.

3. Further, the command areas of the closed M/s. E.I.D. Parry (India) Ltd, Ariyur sugar mill and defunct Puducherry Co-operative Sugar Mills Ltd (PCSM), L.R. Palayam, are kept open as "Common Area" for registration of sugarcane by any sugar mill to enable the sugarcane farmers to register and supply cane to the sugar mills of their choice, subject to mutually agreed terms and conditions between the sugarcane farmer and the respective sugar mill, from the sugar year 2021-22.
