**MEMORANDUM**

Sub: Agri.-Estt. – Circulation of Tentative Seniority List of  
Mazdoors- Reg.

The Hon'ble High Court of Madras, Chennai had directed to implement the award of the Labour Court vide Order dated 27.04.2018 in W.A.No.436/2014. Accordingly, Out of 30 Labourers involved in the case, 13 labourers had attained the age of 60/expired and hence re-engagement orders have been issued to the 17 labourers. Among the 17 Labourers for whom orders have been issued, only 16 of them have reported for duty on 10.06.2019. Their seniority in the post of Full Time Casual Labourer has been fixed assigning their seniority between 354 and 355 i.e. from 354-A to 354-AD (Date of notional re-engagement as FTCLR [15.04.1999] to comply with the court order) and they were placed above Thiru.E.Logaiya (FTCLR Seniority No.355; date of engagement 02.06.1999).

2. The Recruitment Committee for the post of Mazdoor has recommended for absorption of re-engaged Full Time Casual Labourers to the post of Mazdoor on regular basis w.e.f.05.03.2010, the date on which their junior in FTCLR Thiru E.Logaiya was appointed to the post of Mazdoor on regular basis.

3. Accordingly, offer of appointment was issued to the 14 Full Time Casual Labourers who were in service and they have joined duty as Mazdoor on the date shown against each. Hence their seniority in the post of Mazdoor has been assigned above Thiru E.Logaiya in the post of Mazdoor as indicated in the Annexure to the Memorandum.

4. Objections, if any, to the tentative seniority assigned may be made to this Directorate on or before 15.07.2022. If no objection is received by that date, it will be presumed that the officials concerned have nothing to represent against their seniority, indicated therein and the final seniority will be fixed accordingly.
